- The quantity availed under this offer shall be subject to adjustment within overall ACQ of respective unit(s).
- Interested consumers may submit their applications within ten (10) days from issuance this notice. The applications received after the said date will not be considered.
- In the event valid applications against a particular source/grade are received for total quantities exceeding the availability indicated above, the allocation would be considered on prorata basis.
- After processing the applications, quantity agreed to be supplied by SECL against respective unit(s) will be notified.
- Quantities so notified shall have to be lifted by the consumers within 45 days.
- The quantities remaining un-lifted, if any, after expiry of 45 days period shall be counted against Deemed Delivery.
- Supply of coal shall be by '**Road**' mode only and the consumers will be required to make their own arrangement for evacuation of coal on "As-is-where-is-basis".
- In case of Private Power Utilities (IPPs) an affidavit in the enclosed format is required to be submitted for the year 2015-16.
